1. Regarding para 7.24 to 7.36 "Market Value" of Exposure draft

This para is relevant to ULB. So, it is advised to keep this paras.

2. Regarding para 5.34

As per present laws ULB cannot enter into joint venture with private parties. Due to this there may not be any distribution of return to outside parties. It is advised to remove para 5.34 'Ownership distribution'.
